In this system 3 user Login are provided and can be operated at Division office, Circle office & Chief Engineer office level with their respective user ID which is being used for login in WAMIS.

In order to update the system it is required to fill all those useful data's in Work information details, Arbitrator Appointment & Termination details, Award details & Challenge details etc.

All concerned Superintending Engineers & Executive Engineers are requested to take necessary action to update with all details of pending/running Arbitration Cases lying with Departmental Arbitrator or Arbitrator appointed by the Court and also those cases which are pending/running with District Courts & High Court respectively except Land Acquisition Cases on or before 31st May 2021 without fail.


