# CORRECTION IN TRIPURA PWD STANDARD BID DOCUMENT (SBD)-2021

The following corrections has been incorporated in SBD-2021 as 2<sup>nd</sup> amendment.

In Sl. No. 17 of Tripura PWD Form-6 (in page no. 14 of SBD), please read:

"The bid for the works shall remain open for acceptance for a period of one hundred and eighty (180) days from the date of opening of bids. If any bidders withdraws his bid before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit the said earnest money as per Sl. No. 14.10 of Special Instruction to Bidder (S.I.T.B.)."

## in place of:

"The bid for the works shall remain open for acceptance for a period of one hundred and eighty (180) days from the date of opening of bids. If any bidders withdraws his bid before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the work."

So, please correct the above para. in all the copies of Tripura PWD Standard Bid Document (SBD)-2021 shared/circulated earlier. All other para/ clauses / terms & conditions / specifications of the SBD will remain unchanged.
