Employees, the entitlement of different types of Quarters by different categories of State and central Govt. employees has also been revised as per decision of the Government. This is issued as amendment to the earlier Memo No. 19(4)-PWD (C)/987(Pt-I) dated 04.11.2010 of Deputy Secretary, PWD (R&B).

The revised eligibility criteria for different types of quarters based on Grade Pay applicable to State/ Central Government employees etc. as applicable is given below:

Type of Qtrs.	Entitlement for State Govt./All India service and other officers enjoying similar scale
	Revised Grade Pay as applicable
Type-I	Rs. 1300/= to 1900/=
Type-II	Rs. 2000/= to 4400/=
Type-III	Rs. 4600/= to 6600/=
Type-IV	Rs. 6800/= to 7600/=
Type-V	Rs. 7600/= to 8900/=
Type-VI	Apex scale Rs. 10,000/= and above.
